In recent social research, ethnicity has mostly been used as an explanatory variable. It was only after it was agreed that ethnicity, in itself, is subject to change, were the questions of how and why it changes, possible to answer. This multiplicity of ethnic identities requires that we think of each society as one with multiple ethnic dimensions, of which any can become activated in the process of political competition - and sometimes several of them within a short period of time. Focusing on Malaysia and Indonesia, this book traces the variations of ethnic identity by looking at electoral strategies in two sub-national units. It shows that ethnic identities are subject to change - induced by calculated moves by political entrepreneurs who use identities as tools to maximize their chances of winning elections or expanding support base - and highlights how political institutions play an enormous role in shaping the modes and dynamics of these ethno-political manipulations. The book suggests that in societies where ethnic identities are activated in politics, instead of analysing politics with ethnic distribution as an independent variable, ethnic distribution can be taken as the dependent variable, with political institutions being the explanatory one. It examines the problems of voters’ behaviour, and parties’ and candidates’ strategy in a polity that is, to a significant extent, driven by ethnic relations. Pushing the boundaries of qualitative research on Southeast Asian politics by placing formal institutions at the centre of its analysis, this book will be of interest to students and scholars of Southeast Asian Politics, Race and Ethnic Studies, and International Relations.

Exclusion by Elections develops a theory about the circumstances under which ‘class identities’ as opposed to ‘ethnic identities’ become salient in democratic politics, and links this theory to issues of inequality and government efforts to redress the balance. The author explores the argument empirically by examining cross-national patterns of voting behaviour, redistribution and democratic transitions.

This book examines the reasons why young people vote. Viewing political behavior through a psychological lens, this book uses psychological developmental models to test the theory of political identity development and explain how and why young people vote. Rather than studying why young people do not vote, as the majority of the literature does, the book discusses the mechanisms and purpose behind youth voting. Themes of the text include identifying how political identities develop in young people, how leaders can contribute to identity development, and how we can explain differences between young Independents who will vote and those who will not. The first chapter engages the reader with the background for each theoretical element of the book and develops the argument for the book as a whole. Three major substantive chapters discuss and test the theories of political identity development, political leadership as identity role models, and how we misunderstand political independence by not taking into account why young people might choose to identify as an Independent. The final chapter discusses implications for upcoming elections and how this research might better inform people and institutions interested in increasing youth turnout to reformulate their approach. An overarching discussion of identity and the political components of identity development, this book will be of interest to political scientists studying public opinion and voting behavior, campaigns and elections, and political psychology, as well as practitioners such as civic engagement and youth voting groups who wish to engage young people in the political process.

In 2017, a white supremacist rally at the University of Virginia forced many to consider how much progress had been made in a country that, nine years prior, had elected its first Black president.
